CALL TO ORDER

Chairperson, Ms. Amy Pitzer from Concord University, convened the meeting at 11:02 am.

LEGISLATIVE ISSUES

Ms Pitzer asked Mr. Kenneth Harbaugh from Shepherd University to address the various House and Senate bills that should be of interest to ACCE. Mr. Harbaugh distributed a copy of those bills to the members. He specifically referenced and commented on the following bills.

Senate Bill 63-Increasing deposit from excess lottery funds to higher education improvement fund

Senate Bill 247-Authorizing non-base building salary enhancement for certain state employees A bad bill based on Ms. Pitzer's comments

Senate Bill 313-Expanding the number of hours temporary state personnel may work

Senate Bill 373-Relating to Promise Scholarship

Senate Bill 475-Relating to PEIA Finance Board

Senate Bill 519-Authorizing Governor institute employee furlough program

Senate Bill 536-Relating to reorganization and consolidation of the community and technical colleges

Senate Bill 638-Relating to higher education capital facilities

Senate Bill 640-Relating to higher education employees' eligibility for Legislature
