President Colelli:

- Welcome to ACCE members.
- Provided opening remarks on Potomac State College and his background in Higher Education.
- Potomac State has the lowest tuition in WV for baccalaureate degree.
- Adding men and women's lacrosse and cross country.
- Premiere baseball team.
- Offers two year degrees in Agriculture, Business & Economics, Criminal Justice Studies, Business Technology, Equine Production and Management.
- Praised staff (housekeeping and maintenance) on upkeep of buildings on campus. Capital funds in state aren't sufficient for the needs.
- Investing in areas that attract student enrollment. i.e. soccer field.

- Lack of data to compare salaries as CUPA only addresses administrative level.
- Qualified Compensation Analyst required to perform study.

President Colelli

- Would be in favor of performance based funding if he knew what the outcomes are.

- Continued discussion on the number of colleges and universities in the state.
- Community and college partnership for a new recreation center. Partnering with the county, city and college to provide a much needed facility for the community and sharing costs of construction.
