- 1) Welcome from Ronald Hypes, Chief Financial Officer at Bluefield State University Ron Hypes, CFO provided the welcome statement. Bluefield State has brought back housing to the campus and currently house 250 students. Began phase 1 of refurbishment of Bluefield Regional Medical Center which they acquired the building providing the housing for the students and with phase 1 which they are reworking much of the space for the Allied Health coursework. They also plan to complete phases 2 & 3. Bluefield has been able to restart the Mining Engineering program with a focus on all aggregates.
 Campus Carry implementation went smoothly. Were able to provide each student with their own locker for a fee no student took them up on that. Many offices did not ask for signage either. Their sports teams have moved into the CIAA Conference and have proven they are a school to contend with.

5) New Business

Bob Long, ACCE Emeritus, reiterated his availability

Chair Derrico provided an update from Matt Turner of HEPC and new roll out of updated FAFSA.

The US Department of Education is indicating they will not be able to release the 2025-2026 FAFSA in early October, and even a November release may not be possible. Some financial aid reporting deadlines have been extended to January 2025, though institutions were hoping for a more significant extension.



The HEPC will be interested to see the fall 2024 enrollment numbers, as some of the institutions (community colleges in particular) may have done better than expected considering the enormous challenges with the FAFSA. Some of the four-year schools may have been hit harder.

The 2025 legislative session will begin one month later because of the November 2024 election. We will have a new governor and a new Senate president, along with other changes, so there may not be any huge initiatives in higher education. The HEPC will continue to push for the Legislature to fully fund the performance-based funding model, including the yearly inflationary increase, but the HEPC has been asked yet again this year to provide a flat budget. Some legislators are pushing for another tax cut, and many may oppose funding increases that are base-building rather than one-time funding. The HEPC hopes the Legislature will continue to support initiatives such as nursing scholarships, grants, and the expansion of dual credit across the state. Deferred maintenance projects are going well across the state.

Further discussion between ACCE representatives: CTCS would like for us to present October 17 or December 5. After discussion, the group decided to provide the requested presentation in December.

There was discussion of Travel and Meal Reimbursement processes. 18B-5-6(f) in State Code is where code states what has to be paid for ACCE staff members.

West Virginia School of Osteopathic Medicine just began a year long program in Biomedical Sciences.

Southern WV Community and Technical College mentioned having trouble with fraud in the financial aid with bots applying in batches. They have changed their system to include state or federal issued ids. Even with this change, they have found some fake ids coming through.

Thank you to Bluefield State University, Rebekah Hatch, and CFO Ronald Hypes for the amazing and courteous venue they provided.
